PUBLICITY WAIVER

I understand that, while attending this Sierra Pacific Synod Youth Committee (SPSYC) events, I may be recorded by photo and video for the use of SPSYC publicity. I hereby waive all rights, interest, and intellectual property in and of said photos and videos for myself for which I am the legal parent or guardian. I understand that in no case will SPSYC provide or display the name, home address or city, or any personal identification information for any participant in such events.

I further authorize SPSYC to use photos and videos in print, video, and on-line (Internet) versions for the purposes of advertising, reporting, and promoting its non-profit activities. By this authorization, I understand and agree that no participant shall receive remuneration and that all rights, title, and interest to the photos and videos and use of them belongs to SPSYC.

AUTHORIZATION TO CONSENT TO TREATMENT OF A MINOR

I, the undersigned guardian of the above mentioned participant, a minor, do hereby authorize SPSYC and/or adults designated as agents for SPSYC, to consent to any X-ray examination, anesthetic, medical or surgical diagnosis or treatment and hospital care or service, which is deemed advisable and is to be rendered to said minor, under the general or specific supervision of any physician and surgeon licensed under the supervision of the Medicine Practice Act of the state of California or any state within the United States of America, or the medical staff of a licensed hospital, whether such diagnosis or treatments rendered at the office of said physician or at said hospital. It is understood that this authorization is given in advance of any specific diagnosis, treatment, or hospital care being required, but is given as specific consent to any and all such diagnosis, treatment, or hospital care which the aforementioned physician, in the exercise of his best judgment, may deem advisable, to protect the life and health of said minor child.

In consideration of the benefits to be derived from the aforesaid outings, I hereby voluntarily waive any claim against SPSYC, and the owner and driver of the vehicle in which my child (ward) is to receive transportation to said activities.

COVENANT

As a member of the SPSYC I covenant with the group individually and collectively,

To live in accordance with the covenant that God made with me at my baptism: to live among God's faithful people, to hear the word of God and share in the Lord's supper, to proclaim the good news of God in Christ through word and deed, to serve all people, following the example of Jesus, and to strive for justice and peace in all the earth?

To remain an active member and participant in a worshipping community of the Sierra Pacific Synod while I am serving on the SPSYC.

To treat the other people and myself with respect. This includes utilizing appropriate hygiene, eating well, getting enough rest, seeking consent in the participation of others, and communicating with respect and grace. I will do this in person as well as in virtual spaces and mediums.

To abstain from drinking or drugs when I am taking part in SPSYC events or fulfilling my SPSYC duties. This includes retreats, trainings, trips, or any time that I am representing SPSYC.

To abstain from sexual activity when I am taking part in SPSYC events or fulfilling my SPSYC duties. This includes keeping public displays of affection with romantic partners to a minimum during retreats, trainings, or trips.

To contribute to the ministry of the committee by actively participating in the planning and leadership of events. This includes not missing more than one event in a year, participating in conversations online between events, and communicating my absence or participation within reasonable time periods. This also includes actively pursuing opportunities to lead and fulfill needed roles in SPSYC events.

To honor the priorities and goals of the SPSYC ministry above my own interests. This includes not bringing non-participant guests to SPSYC events, sneaking out of events or skipping portions.

By signing this covenant, I acknowledge that my inability to uphold this covenant or the SPSYC Constitution may result in my termination of service on the Sierra Pacific Synod Youth Committee.
